Marilyn Randall has been an AQHA Judge for over 25 years. She is also an accredited judge with NRHA, NRCHA, NSBA, APHA, and ABHA. She also has credentials as a Show Steward for AQHA and NRHA. Her judging has afforded her the opportunity to judge all over the world and to judge many prestigious events such as the AQHA World Shows, the All American Quarter Horse Congress, European Championships, Canadian Nationals, APHA World Show and many others.

For many years Marilyn trained, showed and coached horses and exhibitors to top ten in the AQHA World Shows and All American Quarter

Horse congress. She showed a personally owned and trained horse to the Reserve World Title in AQHA Junior Trail in 1984. One of her students won the AQHA Youth World title in Hunt Seat Equitation and others have won reserve world and congress titles in Western Horsemanship, Trail, Western Riding, and Reining. For 26 years Marilyn also taught in collegiate equine programs at Rocky Mountain College in Billings Montana, and Northwest College in Powell Wyoming.

In 2011, her peers honored her as the AQHA Professional Horsewoman of the year. And in 2018 she was elevated to Honorary Vice President of AQHA. In 2019 Marilyn was again honored by her peers as the Most Valuable Professional. She continues to show horses in the AQHA Versatility Ranch Horse classes when she is not off judging someplace. Marilyn and her husband Ray and band of 4 dogs live in Bridger Montana.
